COURSE DESCRIPTION

The purpose of this activity is to provide a state-of-the-art overview of the clinical care of patients with HIV infection and patients with viral hepatitis for practicing clinicians and other health professionals. The material will be clinically oriented with a focus on the latest pertinent data from clinical trials and basic research. Participants can expect to become more familiar with the primary care of the patient with HIV infection and the management of clinical complications of HIV disease and viral hepatitis. Other related topics will be discussed.

OBJECTIVES

After attending this activity, the participant will demonstrate the ability to:

- Manage patients with comorbid conditions and infections, including tuberculosis and other opportunistic illnesses, renal disease, sexual transmitted infections, viral hepatitis, GYN disease, and anal dysplasia and cancers.
- Identify and be prepared to treat viral hepatitis, particularly Hepatitis C, using recently approved treatments.
- Describe and appropriately prescribe antiretroviral therapy for HIV.
- Work effectively with specialized populations including men who have sex with men, transgender persons, and patients challenged by mental illness and substance abuse.

Internists, Family Practitioners, Infectious Disease Clinicians, Nurses, Nurse Practitioners, Physician Assistants, Nurses, Social Workers, Counselors, Pharmacists, Case Managers and other Allied Health Professionals practicing in the area of HIV and/or viral hepatitis.

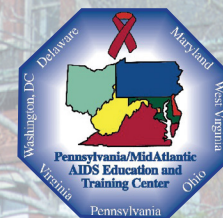
