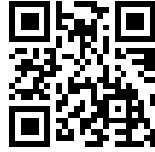

COURSE DESCRIPTION

The purpose of this activity is to provide a state-of-the-art overview of the clinical care of patients with HIV infection and of patients with viral hepatitis for practicing clinicians and other health professionals. The activity will include discussions of HIV epidemiology, clinical management and treatment, and longitudinal care. The material will be clinically oriented with a focus on the latest pertinent data from clinical trials and basic research. Participants can expect to become more familiar with the primary care of the patient with HIV infection and the management of clinical complications of HIV disease.

OBJECTIVES

After attending this activity, the participant will demonstrate the ability to:

- Manage patients with comorbid conditions and infections, including tuberculosis and other opportunistic illnesses, neurologic disease, sexually transmitted infections, viral hepatitis, GYN disease and cancers.
- Identify and be prepared to treat viral hepatitis, particularly Hepatitis C, using newly approved treatments.
- Describe and appropriately prescribe highly active antiretroviral therapy for HIV.
- Work effectively with specialized populations including men who have sex with men and transgender persons.

Internists, Family Practitioners, Infectious Disease Clinicians, Nurses, Nurse Practitioners, Physician Assistants, Social Workers, Counselors, Pharmacists, Case managers and other allied health professionals practicing in the area of HIV.

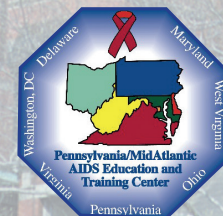
