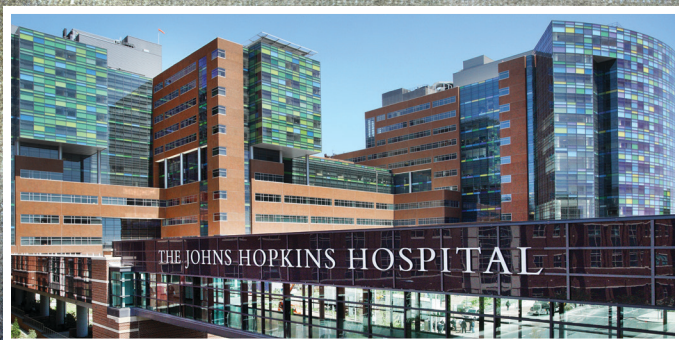

DESCRIPTION

This one day activity will provide attendees an opportunity to review treatment methods, end-of-life considerations, and changes in cognitive function for the aging service members and veterans. Leaders from Veterans Health Administration, VA Maryland Health Care System, and Johns Hopkins Medicine will provide lectures and discussions to improve the care of aging service members and veterans.

Psychiatrists, Psychologists, Primary Care Physicians, Epidemiologists, Nurse Case Managers, Public Health Practitioners, Advanced Practice Nurses, Nurse Researchers, Physician Assistants, Social Workers, Physicians working in the Department of Defense and in the Veterans Health Administration, Geriatric Medicine Internists, General Medicine Internists, and Geriatric providers.
